**Re: Public Health Support for AB 1000 (Reyes) Good Neighbor Policy**

Dear Chair Aguiar-Curry and Members of the Committee:

On behalf of the undersigned health and medical organizations, we write to express our support for Assembly Bill 1000 (AB 1000, Reyes). This legislation seeks to protect local community health within the context of a growing logistics industry. AB 1000, the "Good Neighbor Policy", provides an opportunity to reduce and prevent exposures to carcinogenic diesel exhaust, associated health impacts and disparities in pollution burdens.

Californians face the most difficult air pollution challenges in the nation, but many of our most vulnerable communities bear exceptional burdens due to high concentrations of diesel exhaust. Too often, communities with lower incomes and communities of color experience increased exposures to this toxic air contaminant (TAC) due to the ongoing siting of major pollution sources near homes, schools and other sensitive locations within underrepresented communities. Diesel exhaust can contribute to a wide range of negative health outcomes for those exposed. Asthma and other respiratory impacts, cardiovascular impacts, lung cancer and premature death are associated with diesel exhaust exposure. These impacts represent a neighborhood level impact caused by tens- to hundreds of thousands of daily truck trips generated by massive warehouse projects approved at the local level. These emissions also challenge our ability to attain health-protective ambient air quality standards in California.

AB 1000 calls for a minimum distance of 1,000 feet between new warehousing facilities of 100,000 square feet or more and sensitive receptors like homes, schools and other places where people gather. AB 1000 would also ensure that any new facility approved by a local government within 750-1,000 feet of a sensitive receptor meets a range of technology and operational mitigations including zero-emission equipment, charging/refueling for zero-emission vehicles, idling restrictions, along with public outreach and a cumulative public health and air quality assessment. These health-based recommendations stem from the California Air Resources Board and the California Department of Justice guidance and provide a basis for state-wide health protections in the face of major logistics operations' impacts on community residents.

Our organizations support AB 1000 to ensure that all communities in California are protected against major increases in truck traffic associated with expanded goods movement and logistics operations. The Good Neighbor Policy will provide an opportunity for communities to breathe cleaner air as this industry continues to grow.
